2/ Purpose and Legal Basis of Data Processing

Your personal data will be processed exclusively to allow your participation in the call for expressions of interest, aimed at selecting young people interested in volunteering for the public call for active citizen participation in designing events related to the 2025 Festival delle Culture, promoted by the O.U. Immigration and Citizenship Policies of the Municipality of Ravenna.

The personal data collected will be processed, using electronic and/or paper tools, in compliance with the principles established by current regulations (in particular, Article 5 of the GDPR: principles of lawfulness, fairness, transparency, purpose limitation, data minimization, accuracy, storage limitation, integrity, confidentiality, and accountability) and in ways that ensure the confidentiality and security of the data.

The processing of data belonging to special categories, as defined by Article 9 of the GDPR, will be carried out in compliance with legal provisions and for purposes of significant public interest pursued by the Municipality, in accordance with the provisions of Article 9 of the GDPR and Article 2-sexies of Legislative Decree 196/2003, as amended by Legislative Decree 101/2018 and DM 305/2006.

The personal data provided is processed solely for the examination of the application submitted, pursuant to Article 6, paragraph 1, letter e) of the GDPR. The legal basis for the processing lies in the performance of a task carried out in the public interest or in the exercise of official authority vested in the Municipality of Ravenna for the purpose of publishing the call for expressions of interest.

The processing of the data provided in this application is exclusively aimed at carrying out the activities specified in the call, related to the joint planning processes with the designated offices of the Municipality of Ravenna for the Culture Festival and all connected events. These activities are intended to achieve the objectives outlined in the Municipality's PEG, concerning participatory planning, raising public awareness on migration issues, and strengthening social cohesion through culture.

Therefore, under Article 6, paragraph 1, letter e) of the Regulation, processing is necessary for the performance of a task in the public interest, or the exercise of official authority vested in the Municipality of Ravenna, based on a legal basis meeting the requirements of paragraph 3 of the aforementioned article, and does not require the consent of the data subject.

The personal data provided may be further processed, in accordance with Article 5, paragraph 1, letter b) of the Regulation, for historical, scientific research, or statistical purposes.

3/ Data Disclosure

Your data will be accessible to personnel of the Municipality of Ravenna and may be known, within the prescribed limits, by Data Processors. The personal data of the data subjects will be processed by employees of the Municipality specifically trained by the Data Controller to carry out processing operations, as provided by paragraph 4 of Article 32 of the GDPR.
